1.0 Meeting Called to Order

The Chair, Hunter, calls the meeting to order at 17:32 (49 voting members, including Chair).

3.0 Report on Audited Financial Statements

- Hunter introduces Roland Gagel, BCITSA Director of Finance. The 2019/2020 Audited Financial Statements and financial highlights from the previous year are presented.
- Roland introduces Renee and Kristine, auditors from Smythe LLP, our contracted auditors.
- Audit was conducted in accordance to applicable standards. Renee affirms that the audit was conducted without any issues.

Discussion:

- It was mentioned that Pavilion runs at a deficit. How can this be improved in the future?
 - After students return to campus, the focus will be to establish the menu for the grill and determine proper staffing levels. Management will be continuously

- monitoring performance to maintain good control over staffing levels, costs, and prices.
- Improving marketing to students will be another key focus.
- Staff are confident that there will be improved performance next year.
- Prior to COVID-19, there were already statistics showing that the Habitat pub was not very popular. Are there any contingency plans to pivot operations and commitments in the event that things do not return to normal?
 - The pub will remain closed until there is a significant student population back on campus. The expenses related to the pub are as low as possible this year.
 - The pub is a service that students will always want and has consistently made between \$850,000 to \$900,000 of revenue per year.
 - Management will continue to evaluate and adjust to reflect reality, to ensure that the Association continues to be financially sound and stable.
 - There is no specific plan as it is not possible to know what the future looks like. Guidance will come from Council and the Executive board.
- If the pub was profitable, then there is no need to pivot.
- The joint venture with BCIT was initially \$1.6 million. How much is it now?
 - The initial investment was \$1.6 million, and an additional \$176,000 was spent on capital investments to make the operation as efficient as possible in the future.
 - No further investments are anticipated.
 - The total investment is \$1.8 million and BCIT is responsible for half, as it is a joint venture.
 - The Student Association is the operator of Pavilion, and it is managed by an operating board consisting of staff from both the Student Association and BCIT to ensure that it is meeting student needs.
- Why are all of the loans from Vancity?
 - The banking arrangements of the Association are with Vancity.
 - When the Association initially approached the market for loans, Vancity was the only partner that was willing to provide a loan.
 - Other financial institutions were not willing to provide loans as the Student
 Association leases spaces from BCIT, so the bank cannot seize the properties and
 sell them if the organization were to default.
 - The current loans are commercial loans and not mortgages so it is not possible to get mortgage rates. It would be difficult to get better rates elsewhere.
 - These commercial loans are secured by cash flow rather than assets.
 - The Association continues to work with Vancity as they are very customer serviceoriented and flexible.
- Due to COVID-19, cash flow has been decreased. How is debt currently being serviced?

- The Association is not anywhere close to being insolvent.
- The financial ratios are improving and working capital is increasing again.
- Cash flow is less but is still more than enough to cover debts.
- The bank is satisfied with the financial performance of our organization to date and have no concerns that staff are aware of.
- Was any part of the Canada Emergency Wage Subsidy used to service debt?
 - The wage subsidy was directly tied to wages and was used to bring more staff back.
 - None of the funds from the subsidy were used to service debt, as the Association has the funds to make the payments regardless of the subsidy.
- What happens if things cannot get back to normal? What will Vancity do if the Student Association becomes insolvent?
 - Student fees are still doing reasonably well as they have only decreased by 5%.
 - There is no risk to the Association financially if current service levels are maintained.
 - Vancity has the right to call the loans back, but that would not be done without good reason and there is no good reason now.
 - It is not possible to know what will happen two to three years from now, so it is difficult to speculate.
- Is it safe to say that the Student Association is running on more than 50% debt?
 - It is not clear what is meant by 50% here.
 - The Association is currently at a ratio of \$1.40 net worth to every \$1 of debt.
 - The bank states that our organization can have up to \$3 of debt for every \$1 of net worth.

 - If students decide that they do not want to reappoint Smythe LLP, then staff will go through the process to find new auditors and a Special General Meeting will be called to appoint them.
 - It costs a significant amount of resources and time to find a new firm, and there is no reason to do so as there have not been any issues thus far.

- Could this be explained further?
 - The Bylaws already had a section stating the rights of Student Association members, but it did not specify the rights of students at satellite campuses.
 - For example, a business student studying at the Downtown campus has the right to run for the positions of Chair of the School of Business + Media and Chair of the Downtown Campus. Students in that position also have the right to vote for candidates running for those two Chair positions.
- Is it true that after these amendments, a student will be able to vote for both chair positions if they are studying on the Downtown campus?
 - Yes, that is correct.
- How was the wording changed? Can every student vote for every Executive position?
 - More wording was added to clarify.
 - The five VP positions are the only positions that can be voted on by every BCIT student.
 - For the Chairs, only the students of the school or campus can vote for each Chair.

- Has this situation been an issue in the past?
 - No, we have not seen a significant issue.
 - The committee and staff recognized that there may be confusion due to the wording.
