Outreach Program

Over the years it has been a goal of the BCITSA to try and resolve this struggle of student engagement. In order to do this, an Outreach Program was put into place to ensure the expansion of BCITSA events and programs across all of the BCIT campuses. Because of the many campuses that need to be serviced, we were able to hire a full-time Outreach Coordinator that would visit the campuses on a regular basis to ensure the needs of all students were being met. Aside from creating awareness of all services available to BCIT students, the Outreach Coordinator, Events Manager, and Advocacy Coordinator, were able to successfully offer various fun-filled events across all campuses that brought students a wider sense of community.

The Outreach Program also encompasses a mobile student health plan office in which the BCITSA's Student Plan Coordinator travels to each campus to answer health and dental related questions and help students fill out the appropriate forms in order to set up their plan or opt-out.

Because of the success of the Outreach Program, we are more in touch with students than ever and will be able to offer more programs and events in the future.

Mentorship Program

The 2009-2010 school year was the first year that the Mentorship Program was enacted. In conjunction with the BCIT Alumni Association, the BCITSA was able to introduce Computing and Academic Studies students to industry professionals who offered guidance in successful business and academic strategies. Some of the program goals include helping students make a successful transition from the academic world to the work world, providing an orientation on the industry, discussing strategies for attaining career goals.

Because of the success of the Mentorship Program, we will be able to expand it to other schools and help more students successfully determine and reach their career goals.

New Clubs

The 2009-2010 school year was also a busy year for student clubs. Seven new student clubs were created this year including Business Information Technology Management (BITMAN), Mechanical Engineering Student Society, Christian Fellowship Club (CFC), Geomatics Student Society Club, BCIT Media Club, BCIT Skate, and Zero-One Union Student Club. Student clubs are an essential part of campus life and contribute immensely to the student experience.

Events

In an effort to continue building community around campus, the BCITSA was happy to offer another year of student centered events. One of the most successful events of the year was the Latex Luau party geared at presenting students with harm reduction strategies such as responsible alcohol consumption, drink spiking, safe sex, perceived peer consumption, personal safety, and travel insurance. The Great Hall on the Burnaby campus was transformed into a Hawaiian luau with reggae music and leis galore, gearing students up for the excitment of Spring Break.

Based on student feedback and the success of other events, we were able to add another event to our repertoire: the Zen Lounge. This is a wellness event for students, created to relieve stress during high intensity periods. Students can sign up for free massage treatments or swing by for some complimentary tea and healthy snacks. The Zen Lounge was offered twice during the 2009-2010 school year and both samplings saw an enormous turnout of students seeking sanctuary from their heavy backpacks.

Capital Levy

The BCITSA held a referendum for students to vote on a capital levy, where the proceeds of the levy would go towards the improvement of informal spaces for students to meet and study across all BCIT campuses. The capital levy was passed by the student body and upgrades to informal student spaces are slated to occur within the next year.

Renovations to The Stand stores at SE12 & NE1 and the Uconnect Resource Centre

As we continue to grow and expand our services and programs, we renovated some of our existing businesses as well including The Stands in SE12 and NE1, and the Uconnect Resource Centre. The Stands have been organized to maximize offerings available to customers as well as slightly redesigned to accommodate growing customer traffic. The Uconnect Resource Centre renovations included turning the old Coffee Shop into a meeting room for both students and staff, and creating new offices to accommodate our new full-time Outreach Coordinator.

Pub Profitability

Over the past several years, the Professor Mugs Pub & Grill has run at a deficit. With significant changes to the pub management and day-to-day processes, we are pleased to have 2009-2010 be a profitable year.

Performance Review Program

Up until to and including 2009-2010, the BCITSA staff have partook in a program called Managing For Achievement. For 2010-2011 and onward, a similar but new Performance Review Program was created to help staff with a means of translating the strategic plan into work plans, actions, and behaviors for the year. The new program is also designed to help staff meet strategic plan goals as well as provide the opportunity for both the employee and their manager to initiate and participate in performance discussions, give and receive feedback on progress toward operating objectives, business development objectives, personal development, and effort assessment in relation to the strategic plan. This new plan will take effect in 2010-2011.
