Also as a part of orientation week, the BCIT-SA held our very first outdoor frosh event. Led by our VP Campus Life, with the support from our staff, BCIT, and the local community, Froshfest saw over 500 students in attendance, becoming one of the most successful BCITSA events.

This year also saw the end of our first U-Pass contract. Championed by our VP External, we worked alongside other post-secondary institutions around the province in voicing student concerns and needs during the renegotiation of the U-Pass BC program. After all was said and done, we saw overwhelming referendum results in favour of the new terms and were proud

to announce the renewal of the U-pass BC program for another three years.

The BCITSA also had a busy year constructing more student spaces, which in turn allowed for more student engagement. Anticipating a large expansion of the BCIT downtown campus, we increased student representation in the form of a downtown campus chair position. That being said, we secured an office space that will provide the campus with a much needed physical presence and student voice. With this new position and our strong outreach program, we hope to increase the level of student representation and provide services to a much needed group of students.

Furthermore, continuing with our student lounge initiative, we renovated the SE10 lounge as well as securing an agreement to renovate a student space at our downtown campus. We also ratified the creation of a student space committee as a standing committee to en-

sure oversight in the development of student lounges in the future.

Along with all of these milestones, student engagement was at an all time high with the addition of seven new student clubs, record breaking visits to the U-connect, and an increasing demand of services from all our campuses. Although we did face our share of challenges along the way, I am confident that we better positioned ourselves to help enhance student life in the years to come.

Lastly, I would like to give thanks to the executive team and staff for their patience and immense amount of hard work and dedication they poured into the BCITSA in the past year. Looking back at what we have accomplished, I am always amazed at how far the BCIT Student Association has come. Working with students on a daily basis offers us a constant source of inspiration to better the Association's offerings. We are always looking at ways to reinvent ourselves to enhance student life and experience. Constant evolution is one of our goals.

Last year, agreements were negotiated with BCIT giving us access of the entire SE2 building. Consequently, we moved our offices to the third floor and began renovating the second floor in order to launch a new student space in the 2013-2014 school year.

It took over 20 years to finally complete students' vision of creating a true student centre for students by students. Back in 1986, a group of students proposed the creation of a student campus centre. The building was built in 1995; however BCIT still occupied the third floor of this centre. This year, we realized what so many student leaders had dreamed of doing. The dream was kept alive and most importantly realized. It is exciting to see that this renovation project is only the beginning of reinventing the third floor of SE2: planning is scheduled for 2013-2014 with construction starting in 2014.

Another significant addition to the BCITSA services was the construction of the BCITSA Childcare Centre. As part of the 2011 agreements with BCIT, we were able to renovate the SE41 building and create a modern and well-designed childcare centre with a capacity of 25 children, ages 30 months and over, for BCIT students and staff. We proudly opened the BCIT Childcare Centre in January 2013. This is the only childcare centre open for our students, and hope-

fully its success will demonstrate a value to BCIT.

These two capital projects represent an investment of well over one million. It exhibits our constant commitment to ensuring that BCITSA enhances students' experience. Beyond capital investment, the BCITSA team continued to build on the success of programs such as our special events, Peak Leadership and health services, just to name a few. Our retail businesses have also continued their quest to offer services.

We remain dedicated to connecting with students and we make it imperative that student engagement is part of our business model. I thank everyone who contributes every day to the success of the BCIT Student Association. Without each and every one of you, the BCITSA would not be where i

#### **ENGAGEMENT:**

The BCITSA expansion projects were not the only things breaking new ground; our staff kept busy offering new services, events, and maximizing our outreach to keep in touch with student needs.

BCITSA launched its own Craigslist-type site to provide a specialized buy/sell/trade service to the BCIT community. An ID card program was also introduced to expand the revenue opportunities and increase options for third parties wanting to be involved with BCIT students.

Our Outreach department and social media team continued their positive growth, seeing an increase in participation from our satellite campuses and even part-time studies, a large relatively untapped market.

Because of the successful

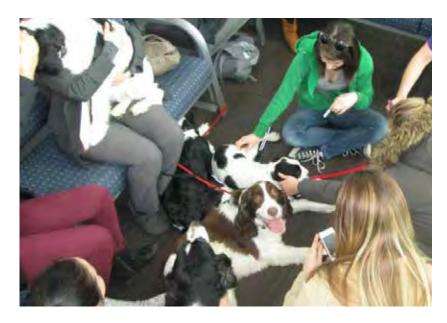

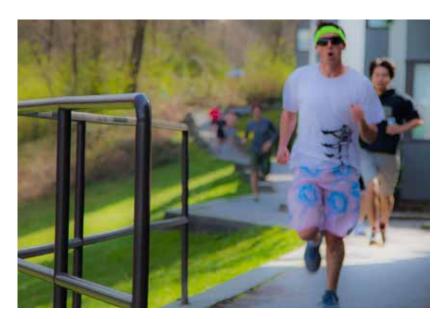
